Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 10, 2025, placed the rating(s) of OM ASSOCIATES (OA) under the 'issuer non-cooperating' category as OA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 24, 2026, February 03, 2026, February 13, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of OA have been revised on account of non – availability of requisite information.
