Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 13, 2025, placed the rating(s) of Aditya Auto Engineering Private Limited (AAEPL) under the 'issuer non-cooperating' category as AAEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AAEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 30, 2025, January 09, 2026, January 19, 2026, among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Aditya Auto Engineering Pvt Ltd. (AAEPL) was incorporated as a private limited company in the year 2009 by Mr. Gopala Reddy B. The company is engaged in the business of manufacturing of Auto Mechanical Support Systems like bodies of Tippers, Trailers, Lorries, Cement Carriers, Granite Carriers, Oil Tankers and Water Tankers etc. The company is also undertaking job works of body building works on behalf of M/s Hyva India Pvt. Ltd., M/s Scania Commercial Vehicles India Pvt Ltd. etc. who are engaged in similar activities.

Status of non-cooperation with previous CRA: Brickwork has continued the ratings assigned to the bank facilities of AAEPL to the 'issuer not-cooperating' category vide press release dated April 07, 2025, on account of its inability to carryout review in the absence of requisite information from the company.
