Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 11, 2025, placed the rating(s) of Arunachala Spinning Mills India Private Limited (ASMIPL) under the 'issuer non-cooperating' category as ASMIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ASMIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 28, 2025, January 07, 2026, January 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of ASMIPL have been revised on account of non-availability of requisite information.

The company mainly produces cotton yarn of 40's and 34's count mainly used in the hosiery industry. The company has an installed capacity of 18000 spindles with manufacturing capacity of 28.87 lakh Kgs of yarn as on November 31, 2023. The manufacturing unit is located at Dharapuram, Tamil Nadu.
