### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 06, 2025, placed the rating(s) of J and G Transformer Private Limited (JGTPL) under the 'issuer non-cooperating' category as JGTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JGTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 23, 2025, January 02, 2026, January 12, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Gurgaon (Haryana) based J and G Transformer Company (JGTPL) was originally established as proprietorship firm by Mr. Manohar Lal Bera in 2009. The firm was reconstituted into private limited company in 2015 and is currently being managed by Mr. Manohar Lal Bera and Mrs. Usha Gera. JGTPL is engaged in manufacturing of power & distribution transformers. JGTPL is also engaged in maintenance and repairing of transformers. These transformers are mainly supplied to state electricity boards of Haryana (Uttar Haryana Bijli Vitran Nigam and Dakshin Haryana Bijli Vitran Nigam) wherein the orders are acquired through bidding.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of JGTPL into 'Issuer not-cooperating' category vide press release dated February 04, 2025, on account of non-availability of requisite information from the company.
