Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated February 06, 2025, placed the rating(s) of Royalline Resources Limited (RRL) under the 'issuer non-cooperating' category as RRL had failed to provide information for monitoring of the rating and as agreed to in its Rating Agreement. RRL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 23, 2025, January 02, 2026, January 12, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Incorporated as Sacvinam Exports Private Limited in 1994, Royalline Resources Limited (RRL) is engaged mainly in the export of iron ore fines and mill scales along with trading of imported steam coal, sugar, soya bean, cashew nuts and other agro commodities. RRL has facilities (warehousing) of exports from all the major ports from India viz Vizag, Haldia, Paradip, Chennai and Kandla. RRL is a part of the Radiant Group of companies. The Radiant group is headquartered in Singapore and presence in 5 continents and 11 countries. Royalline Resources Limited is the flagship company of the group.

Status of non-cooperation with previous CRA: India Rating has continued the rating assigned to the bank facilities of RRL into ISSUER NOT COOPERATING category vide press release dated July 18, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
