Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 14, 2025, placed the rating(s) of Banaras Swarn Kala Kendra Private Limited (BSKKPL) under the 'issuer non-cooperating' category as BSKKPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BSKKPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 31, 2025, January 10, 2026, January 20, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
