### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated February 25, 2025, placed the rating(s) of Buildmate Projects Private Limited (BPPL) under the 'issuer non-cooperating' category as BPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 11, 2026, January 21, 2026, January 31, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Buildmate Projects Private Limited was incorporated in the year 1991 and promoted by Mr. Kesava Reddy and Mrs. Jayasree. The company is engaged in manufacturing and supply of equipments for AAC (Autoclaved Aerated Concrete) Plants used in construction industry. It usually takes up an entire project on turnkey basis, i.e., from manufacturing of the machinery to installation (which includes erection, commissioning, installation among others) at customers' place. The company has an installed capacity for setting up seven plants per annum.
