Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 06, 2025, placed the rating(s) of Kaila Devi Healthcare Services Private Limited (KDHSPL) under the 'issuer non-cooperating' category as KDHSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KDHSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 23, 2025, January 02, 2026, January 12, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
