### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated February 24, 2025, placed the rating(s) of Safe & Secure Logistic Private Limited (SSLPL) under the 'issuer non-cooperating' category as SSLPL had failed to provide information for monitoring of the rating and as agreed to in its Rating Agreement. SSLPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 10, 2026, January 20, 2026, January 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SSLPL have been revised on account of non-availability of requisite information.
