### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated February 19, 2025, placed the rating(s) of P Damodara Raju (PDR) under the 'issuer non-cooperating' category as PDR had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PDR continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 05, 2026, January 15, 2026, January 25, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
