### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 20, 2025, placed the rating(s) of Ganesh Tamuli Engineering Private Limited (GTEPL) under the 'issuer non-cooperating' category as GTEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GTEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 06, 2026, January 16, 2026, January 26, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the Company

Ganesh Tamuli Engineering Private Limited (GTEPL) was established in 1982 as a proprietorship entity in the name of M/s Ganesh Tamuli (GT) at Kamrup in Guwahati, Assam. Later on, during December 2006, the entity was converted to private limited company as GTEPL. The company participates in the tender process of various Government projects like PWD Assam, IIT Guwahati etc. for their civil construction projects like road, building, pavements and related ancillary works.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of GTEPL into ISSUER NOT COOPERATING category vide press release dated June 05, 2025 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of GTEPL into ISSUER NOT COOPERATING category vide press release dated August 11, 2025 on account of its inability to carry out a review in the absence of requisite information.
