### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 06, 2025, placed the rating(s) of Hajra Medical Agency Private Limited (HMAPL) under the 'issuer non-cooperating' category as HMAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HMAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 23, 2025, January 02, 2026, January 12, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

"Hajra Medical Agency Private Limited" (HMAPL) was formed in the 1982 as a proprietorship entity by Mr. Subrata Kumar Hajra of Kolkata (West Bengal). Since inception, the company is engaged in distribution of pharmaceuticals products. Subsequently in the year 2001, HMAPL was converted into private limited company. The company purchases the goods in bulk quantities from the large drug manufacturers and sells it to stockiest on stock & sales basis. The company has six warehouses located in Kolkata, out of which four are owned and two is on rent.
