### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 18, 2025, placed the rating(s) of AKMB Projects Private Limited (APPL) under the 'issuer non-cooperating' category as APPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. APPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 04, 2026, January 14, 2026, January 24, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Kolkata based, AKMB Projects Private Limited (APPL) was incorporated on May 21, 2010. Since its inception, APPL has been engaged in civil construction business in the segments like railway projects, construction of roads, bridges etc. The company procures orders through tender and executes orders floated by the various Govt. entities.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of APPL into ISSUER NOT COOPERATING category vide press release dated August 11, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
