Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated March 11, 2025, placed the rating(s) of Ganpati Builders (GB) under the 'issuer non-cooperating' category as GB had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GB continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 25, 2026, February 04, 2026, February 14, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of GB have been revised on account of non-availability of requisite information.

About the Firm

Sri Ganganagar (Rajasthan) based Ganpati Builders (GB) was formed in 2013 by Mr. Om Prakash Sharma, Mr. Banwari Lal Sharma, Mr. Hansraj Sharma and Mr. Rajesh Sharma as a partnership concern. GBS is registered as 'A' class contractor with Public Works Department, Uttarakhand (PWD) and is eligible for bidding of orders all over India. It is engaged into activity of construction of roads and bridges. Till FY18, GBS were executing contracts of Gawar Construction Limited (rated CARE AA-; Positive/ CARE A1+) on sub contract basis and since FY19 GBS started participating in state government tenders under its own name. GBS gets orders through bidding and tendering process where it majorly caters contracts for the states of Rajasthan, Himachal Pradesh, Assam, Arunachal Pradesh and Manipur. GBS procures raw materials viz. bitumen, ready mix concrete, metal and diesel from suppliers located in nearby areas. GBS has its registered office is located at Sri Ganganagar.
