Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 27, 2025, placed the rating(s) of CGR Collateral Management Limited (CCML) under the 'issuer non-cooperating' category as CCML had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CCML continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 13, 2026, January 23, 2026, February 02, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

CGR Collateral Management Limited (CCML) was incorporated by Mr Aman Deep in December 2012. CCML offers modern, scientific, IT enabled storage services for all types of agro commodities covering more than 57 locations spread across 6 states. The company had 175 storage facilities having a capacity of over 2.98 Lakh MT as on June 30, 2018. CCML also provides commodity assaying services as it is an NCDEX and NCDEX e Markets Ltd (NeML) appointed Assayer. The company also provides the advisory and collateral management services in partnership with the associate banks and Non-Banking Financial Companies (NBFCs). CCML has tie-up with 8 nationalized banks for providing collateral management services.
