Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 05, 2025, placed the rating(s) of Jindal PRL Infrastructure (Joint Venture) (JPI) under the 'issuer non-cooperating' category as JPI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JPI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 19, 2026, January 29, 2026, February 08, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
