Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 18, 2025, placed the rating(s) of Patanjali Chikitsalaya - Chennai (PCC) under the 'issuer non-cooperating' category as PCC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PCC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 04, 2026, January 14, 2026, January 24, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Patanjali Chikitsalaya (PCC) was established in January 2009 as a proprietorship concern by Smt. Suman Devi Lath in Chennai, Tamil Nadu. The firm is involved in trading of FMCG products and is an authorized dealer of Patanjali Ayurved Limited, Haridwar and Divya Pharmacy, a manufacturing unit of Patanjali Yogpeeth. The products sold by PC are Ghee, Face creams, Medicines, Soaps, Detergents, Wheat flour, Sunflower oil, Honey, etc. The registered office of the firm is located at Egmore in Chennai (Tamil Nadu).

Status of non-cooperation with previous CRA: Acuite has continued the ratings assigned to the bank facilities of PCC to the 'issuer not-cooperating' category vide press release dated February 13, 2025 on account of its inability to carryout review in the absence of requisite information from the firm.
