Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 11, 2025, placed the rating(s) of Rockdrill Projects Private Limited (RPPL) under the 'issuer non-cooperating' category as RPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 25, 2026, February 04, 2026, February 14, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Jaipur based RPPL was formed as M/s Amit Arora, a proprietorship firm, in 1992 with Mr Amit Arora as proprietor. Later, the firm was converted into a partnership firm, M/s Rockdrill Projects in 2000 with Mr Amit Arora and Mr Hanuman Singh Mehta. Subsequently, the partnership firm was converted into private limited company in 2010 and the name was changed to RPPL. The company is involved in execution of projects involving laying of ducts, cables and pipelines through trenchless technology (horizontal directional drilling process) for its customers spanning across different sectors including Telecommunication, Infrastructure, Power and Oil & Gas.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of RPPL into Issuer Not Cooperating category vide press release dated February 05, 2026 on account of its inability to carry out a review in the absence of requisite information.
