Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 05, 2025, placed the rating(s) of Lord Wheels Private Limited (LWPL) under the 'issuer non-cooperating' category as LWPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LWPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 19, 2026, January 29, 2026, February 08, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Meerut, Uttar Pradesh, based Lord Wheels Private Limited (LWPL) was incorporated in 2015 as a private limited company and is currently being managed by Mr. Pankaj Veerbhan, Ms. Radhika Veerbhan and Mr. Vedpal Singh. LWPL is an authorized dealer of Honda Cars India Limited (HCIL). The company operated through two 3S (Sales, spare & services) facilities in Dehradun under the brand name of Admire Honda.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of LWPL into 'Issuer not-cooperating' category vide press release dated January 30, 2026 on account of non-availability of requisite information from the company.

BRICKWORK has continued the ratings assigned to the bank facilities of LWPL into 'Issuer not-cooperating' category vide press release dated March 23, 2026 on account of non-availability of requisite information from the company.
