Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 19, 2025, placed the rating(s) of Aarti Suitings Private Limited (ASPL) under the 'issuer non-cooperating' category as ASPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ASPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 02, 2026, February 12, 2026, February 22, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Bhilwara based Aarti Sutings Private Limited (ASPL) was incorporated in 1994 by Mr. Nand Kishore Jindal, Mr. Madhur Jindal and Mrs. Nidhi Jindal. The company is engaged in the manufacturing of grey fabrics and sells grey and finished fabrics in the market. The company gets processing work done on job work basis from other processing units. The company is also engaged in trading of grey and finished fabrics.
