Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 13, 2025, placed the rating(s) of Lemon Electronics Limited (LEL) under the 'issuer non-cooperating' category as LEL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LEL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 30, 2025, January 09, 2026, January 19, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Lemon Electronics Limited was incorporated on June 9, 2008 was promoted by Mr. Sandeep Mushran, Mr. M.S. Malik and Mr. Gopal Kalra. Mr. Kapil Chugh, the managing director of the company, took over the management of the company in February, 2016. The company is primarily engaged in trading and assembling of mobile handsets under the brand name of 'Lemon'. The company has its assembling unit located in Noida, U.P.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of LEL into 'Issuer not-cooperating' category vide press release dated December 10, 2025 on account of non-availability of requisite information from the company.

BRICKWORK has continued the ratings assigned to the bank facilities of LEL into 'Issuer not-cooperating' category vide press release dated July 21, 2025 on account of non-availability of requisite information from the company.
