### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 11, 2025, placed the rating(s) of Orchid Marine (OM) under the 'issuer non-cooperating' category as OM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 28, 2025, January 07, 2026, January 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

OM is engaged in export of processed sea food products with the present installed capacity of 20 tonnes per day. The sea food products include Shrimps, Yellow Fin Tuna, Skipjack Tuna, Yellow Clam, Grey Clam, Bagai, Green Mussel, Shark, Sardine Frozen Shrimp, PUD Shrimp, PD Shrimp, PTO Shrimp, Tiger Prawn, HLSO Shrimp, Deep Sea Shrimp, Blue Swimming Crab, Three Spotted Crab, Skipjack Tuna, Leather Jacket Black, Leather Jacket Yellow, Snapper etc. The finished products are sold under the brand name "Orchid".
