Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) has withdrawn the outstanding rating of 'CARE B+; ISSUER NOT COOPERATING/ CARE A4; ISSUER NOT COOPERATING [Single B; Plus; ISSUER NOT COOPERATING/ A Four; ISSUER NOT COOPERATING]' assigned to the bank facilities of Innovassynth Technologies (india) Limited (ITIL) with immediate effect. The above action has been taken as the company is dissolved (without winding up) as ordered by the Hon'ble National Company Law Tribunal (NCLT), Mumbai Bench vide order no. C.P.(CAA)/218(MB)/2025 in C.A.(CAA)/145(MB)/2025 pronounced on November 14, 2025, under the Insolvency & Bankruptcy Code.
