Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 28, 2025, placed the rating(s) of Sheetal Agro Food Park Private Limited (SAFPPL) under the 'issuer non-cooperating' category as SAFPPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAFPPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 14, 2026, January 24, 2026, February 03, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Kanpur (U.P) based Sheetal Agro Food Park Private Limited was incorporated in January 2010 and is currently being managed by Mr. Mehboob Alam and Mr. Masroor Alam. The company is engaged in renting of its cold storage facility for potatoes to the local farmers in Kanpur, Uttar Pradesh.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SAFPPPL into Issuer Not Cooperating category vide press release dated December 18, 2025, on account of its inability to carry out a review in the absence of requisite information.
