Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated February 12, 2025, placed the rating(s) of K. N. Singh Infratech Private Limited (KNSIPL) under the 'issuer non-cooperating' category as KNSIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KNSIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 29, 2025, January 08, 2026, January 18, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
