CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 28, 2025, placed the rating(s) of Vasu Metplast Private Limited (VMPL) under the 'issuer non-cooperating' category as VMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 14, 2025, December 24, 2025, January 03, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Kanpur based, Vasu Metplast Private Limited (VMPL) was incorporated in 2013 by Mrs. Sweta Kanodia and Mr. Saurabh Agarwal. VMPL started its commercial operations in 2015 and is engaged in the manufacturing of polyfilms which find its application in the packaging industry. The primary raw material is plastic granules which are procured mainly from local suppliers in Uttar Pradesh. VMPL sells its finished goods to entities such as Reliance Industries Limited and Haldia Petro Chemicals
