Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 07, 2025, placed the rating(s) of Hans Raj Agros Private Limited (HRAPL) under the 'issuer non-cooperating' category as HRAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HRAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 21, 2026, January 31, 2026, February 10, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Hans Raj Agros Private Limited (HRAPL) was incorporated in April 1996 and is currently being managed by Mr. Subhash Chander Kamra, Mrs. Kanta Kamra, Mr. Rahul Kamra and Mr. Ranjam Kamra. The company is engaged in processing of paddy at its manufacturing facility located in Fazilka, Punjab with an installed capacity of processing 67,000 Tonnes of paddy per annum.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of HRAPL into Issuer Not Cooperating category vide press release dated February 24, 2026 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of HRAPL into Issuer Not Cooperating category vide press release dated April 20, 2026 on account of its inability to carry out a review in the absence of requisite information.
