Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 27, 2025, placed the rating(s) of Naxalbari Flour And Rice Mill Private Limited (NFRMPL) under the 'issuer non-cooperating' category as NFRMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NFRMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 13, 2026, January 23, 2026, February 02, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

Naxalbari Flour And Rice Mill Private Limited (NFRMPL) was established in March 2012. The company is engaged in milling of raw/parboiled non-basmati rice. The milling unit of NFRM is located at Dhana Jote, District – Naxalabri in Darjeeling, West Bengal with a paddy processing capacity of 12 metric tonne per hour. NFRMPL procures paddy from farmers & local agents and sells its finished products through the wholesalers and brokers located in Darjeeling, West Bengal. The company has started its commercial operations from June 2014.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of NFRMPL into ISSUER NOT COOPERATING category vide press release dated June 13, 2025 on account of its inability to carry out a review in the absence of requisite information.

Acuite has continued the rating assigned to the bank facilities of NFRMPL into ISSUER NOT COOPERATING category vide press release dated December 11, 2025 on account of its inability to carry out a review in the absence of requisite information.
