Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated March 03, 2025, placed the rating(s) of Khem Traders (KT) under the 'issuer non-cooperating' category as KT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 17, 2026, January 27, 2026, February 06, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of KT have been revised on account of non-availability of requisite information.

About the company

Established in 2008, Khem Traders (KT) was promoted as a partnership firm by Mr Khem Prakash Kiri and Mr Ajay Kiri to set up a rice milling and processing plant in the state of Chhattisgarh. The firm has been engaged in milling and processing of rice at its plant located at Dhamtari, Chhattisgarh with an installed capacity of 102,000 MTPA. This apart, the firm also does custom milling for the state government of Chhattisgarh.

Status of non-cooperation with previous CRA: Infomercs has moved the ratings assigned to the bank facilities of KT into issuer non-cooperation category vide press release dated April 07, 2026 due to its inability to carry out a review in the absence of requisite information from the company.
