Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 24, 2025, placed the rating(s) of Raj Electricals (RE) under the 'issuer non-cooperating' category as RE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 10, 2026, January 20, 2026, January 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Jaipur-based (Rajasthan) RE was formed in 2011 by Mr. Anurag Sharma as a proprietorship concern. RE is registered as an 'A' class (second highest in the scale of AA to E) contractor with Rajasthan State Electricity Boards. It executes electrical contracts for Jaipur Vidyut Vitran Nigam Limited (JVNL), Jodhpur Vidyut Vitran Nigam Limited (JdVVNL), Ajmer Vidyut Vitran Nigam Limited (AVVNL) and contract work includes erection of power line with material and without material. It also undertakes the turnkey projects given by the power department where work includes survey, erection of power lines, supply of material (transformer, power pole, power lines).
