### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 04, 2025, placed the rating(s) of Chandra Fabrics Private Limited (CFPL) under the 'issuer non-cooperating' category as CFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 21, 2025, December 31, 2025, January 10, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of CFPL have been revised on account of non-availability of requisite information.

Chandra Fabrics Private Limited was incorporated as a private limited company in 1995 and is promoted by Mr. Gunender Kumar Jain. Presently, Mr. Ankur Jain and Mrs. Shashi Jain are looking after the business operations. Chandra Fabrics Private Limited is engaged in the business of manufacturing and export of all kinds of readymade garments, through its two manufacturing units located at Tronica City and one in Delhi, The company majorly exports readymade garments. For knitted clothing orders, CFPL procures yarn and then develops it (knitting, printing and dyeing) through job work from various outsourcing units based in Delhi. For woven clothing orders, they procure woven fabric from Bhilwara, Rajasthan and then do the cutting, stitching and designing. It procures other raw materials viz. thread, zips, designing materials, labels, buttons from various suppliers based in Delhi.
