Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 10, 2025, placed the rating(s) of P. R. Pote (Patil) Education And Welfare Trust (PRPEWT) under the 'issuer non-cooperating' category as PRPEWT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PRPEWT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 24, 2026, February 03, 2026, February 13, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of PRPEWT have been revised on account of non-availability of requisite information.
