Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 03, 2025, placed the rating(s) of Uniworld Sugars Private Limited (USPL) under the 'issuer non-cooperating' category as USPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. USPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 20, 2025, December 30, 2025, January 09, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

USPL is an equal joint venture between ED & F Man Sugar Netherlands BV (EDF), one of the largest commodity traders in the world markets and Simbhaoli Sugars Limited (SSL), having one of the largest sugar refineries in India. USPL is engaged in refinery operations which processes raw sugar into white refined sugar through ION exchange process and sells its product under the brand name "Tiger". SSL and EDF formed a joint venture to set up a manufacturing facility at the port of Kandla, Gujarat.
