### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 03, 2025, placed the rating(s) of Shiv Health Foods LLP (SHFL) under the 'issuer non-cooperating' category as SHFL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SHFL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 17, 2026, January 27, 2026, February 06, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of SHFL have been revised on account of non – availability of requisite information.

### About the Firm

Kota based (Rajasthan); SHFL is a limited liability partnership (LLP) established in 2010 by five partners comprising members from Saboo family (i.e. promoter's family) and a corporate entity Shiv Agrevo Limited, (having 35% holding in SHFL). SHFL, an ISO 22000:2005 compliant and a Food Safety Management Systems (FSMS) certified entity, is engaged in the business of processing milk and producing milk products from its manufacturing facility located in Kota, Rajasthan under the band name of 'Kota Fresh'. Further, SHFL had started plant for manufacturing of soya proteins with installed capacity of 10 MTPD in May, 2018 and sells the same under brand name of 'Prowise'.
