### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 25, 2025, placed the rating(s) of Diamond Hometex India Private Limited (DHIPL) under the 'issuer non-cooperating' category as DHIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DHIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 11, 2026, January 21, 2026, January 31, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, CareEdge Ratings's opinion is not sufficient to arrive at a fair rating.

### About the company

Panipat-based, (Haryana) Diamond Hometex India Private Limited (DHIPL) was incorporated in 2013. The company is currently promoted by Mr. Nitin Singhal, Mr. Vikas Garg and Mr. Rohit Bansal. DHIPL was incorporated with an objective to manufacture mink and polar blankets. The company has set up a manufacturing plant for manufacturing blankets at Panipat and DHIPL commenced its operations from August, 2014.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of DHIPL under Issuer Not Cooperating category vide press release dated September 16, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
