Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 29, 2025, placed the rating(s) of Keya Foods International Private Limited (KFIPL) under the 'issuer non-cooperating' category as KFIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KFIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 15, 2025, December 25, 2025, January 04, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of KFIPL have been revised on account of non – availability of requisite information

Keya Foods International Private Limited (KFIPL; formerly known as Amalgam Speciality Foods (India) Pvt. Ltd) is engaged in manufacturing and trading of Herbs, Spices and Seasonings (HSS), sauces, snacks, Ready to Cook (RTC) soups, pickles, paste, and operates under 'Keya' brand. The company has manufacturing facilities at Kuthiathode, Kerala with a distribution network driven by both Modern Trade (MT) and General Trade (GT), along with e-commerce platforms. KFIPL was incorporated as a private limited company on August 10, 2007. As on Mar 31, 2024, ~73.35% shareholding is by True North Trustee Company Pvt. Ltd. [(TNTCPL) owned by True North Fund IV].
