Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 04, 2025, placed the rating(s) of Arjun Nirman Infrastructures Private Limited (ANIPL) under the 'issuer non-cooperating' category as ANIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ANIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 18, 2026, February 28, 2026, March 10, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings for ANIPL have been revised on account of non-availability of requisite information.

The company mainly executes contracts of construction & maintenance of roads, construction of sewage lines and sewage treatment plants, installation and commissioning of water supply lines and construction of EWS houses. ANIPL is registered 'A' class approved contractor with Public Works Department (PWD), Madhya Pradesh. Further, the company also sub-lets some of its contracts to its group concern Madhya Bharat Telecom Infrastructures (MBTI).
