Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 27, 2025, placed the rating(s) of KGN Motors Private Limited (KMPL) under the 'issuer non-cooperating' category as KMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 13, 2026, January 23, 2026, February 02, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Incorporated in 2007 in Pune, Maharashtra, KGN Motors Private Limited (KMPL) is a private limited company promoted by Ms. Hasina Riyaz Inamdar and Mr. Mubin Riyaz Inamdar and is a flagship company of KGN Group. The company is an authorized dealer for trucks and buses of Ashok Leyland Limited (ALL). The company was initially into spares and services business for ALL and subsequently ventured into sales business [3S (sales, spares and services)] for ALL in 2014.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of KMPL under Issuer Not Cooperating category vide press release dated July 14, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
