Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated February 04, 2025, placed the rating(s) of Annapurna Traders (AT) under the 'issuer non-cooperating' category as AT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 21, 2025, December 31, 2025, January 10, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the Firm

Annapurna Traders (AT) was established as a proprietorship firm in 2007. The firm is primarily engaged in trading of wheat, soyabean, chana and makka etc. The firm has two manufacturing units located at Bematara and Nandul, Chhattisgarh with aggregate processing capacity of 11,520 metric ton per annum (MTPA). AT procures paddy from farmers & local agents and sells its products through the wholesalers and distributors located in Chhattisgarh. Mr. Manish Kumar Gilda, having more than a decade of experience in the rice milling industry and trading business, looks after the day to day operations of the firm along with a team of experienced professionals who have rich experience in the similar line of business.

Status of non-cooperation with previous CRA: Acuite has continued the rating assigned to the bank facilities of AT into ISSUER NOT COOPERATING category vide press release dated February 10, 2026, on account of its inability to carry out a review in the absence of requisite information from the firm.
