### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 11, 2025, placed the rating(s) of J.B.R. Technologies Limited (JTL) under the 'issuer non-cooperating' category as JTL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JTL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 25, 2026, February 04, 2026, February 14, 2026, among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The company is mainly engaged in operating the waste water treatment plant at four locations (2 in Ludhiana, Punjab, one in Nayal Nangal (Punjab) and one in Rajasthan).
