### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 18, 2025, placed the rating(s) of Falcon Steels (FCS) under the 'issuer non-cooperating' category as FCS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. FCS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 04, 2026, January 14, 2026, January 24, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the Firm

Falcon Steels (FCS) was established as a partnership firm in February 2016 and is currently being managed by Mr. Akhil Singhal, Mr. Raj Kumar, Mr. Pardeep Kumar Singhal, Mr. Rahul Singhal and Mr. Sanchit Singhal as its partners. The commercial operations of the firm started in April 2017. FCS is engaged in manufacturing of Stainless steel (SS) products at its facility located in Kaithal, Haryana. The main products include Stainless steel (SS) tubes, SS Pipes, SS circles, SS rounds and SS squares.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of FCS into Issuer Not Cooperating category vide press release dated June 10, 2025 on account of its inability to carry out a review in the absence of requisite information.
