Rationale & Key Rating Drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 03, 2025, placed the rating(s) of Samaro Global Industries Private Limited (SGIPL) under the 'issuer non-cooperating' category as SGIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 17, 2026, January 27, 2026, February 06, 2026 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Samaro Global Industries Private Limited (SGIPL) was incorporated in October 2019, by Mr. Paresh Vinod Parekh and Mr. Hareesh Paresh Parekh to setup manufacturing of Stone Plastic Composite (SPC) and Luxury Vinyl Tiles (LVT) flooring plant at Umbergaon, Gujarat.

Status of non-cooperation with previous CRA: India Ratings has continued the ratings assigned to the bank facilities of SGIPL to 'Issuer Not Cooperating' category vide press release dated October 17, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
