Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 03, 2025, placed the rating(s) of Food Service India Private Limited (FSIPL) under the 'issuer non-cooperating' category as FSIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. FSIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 17, 2026, February 27, 2026, March 09, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of FSIPL have been revised on account of non-availability of requisite information.

About the company

Incorporated in November 2015, FSIPL is promoted by Mr. Ajay Mariwala. It started its commercial operation from September 2016 post acquisition of food service division from VKL Seasonings Pvt. Ltd (VSPL) vide business transfer agreement. FSIPL is engaged in business of manufacturing (in house or through third parties) and selling of spices, sharbats, gravies & sauces and bakery premixes in domestic market as well as export markets. Manufacturing/processing facilities are located at Aleppy, Rabale, Surat, Pune and Thuravoor. FISPL is also engaged in trading of food seasoning products. FSIPL has entered into an agreement wherein, VSPL supplies seasoning products to FSIPL on a margin basis, in accordance with the transfer pricing norms. FSIPL sells its products through independent distributors or to Hotels, Restaurants and Caterers (HORECA).
