Rationale and key rating drivers

CARE Ratings Limited(CareEdge Ratings) had, vide its press release dated April 03, 2025, placed the rating(s) of Sbc Minerals Private Limited (SMPL) under the 'issuer non-cooperating' category as SMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 17, 2026, February 27, 2026, March 09, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of SMPL have been revised on account of non-availability of requisite information.

New Delhi based, SBC Minerals Private Limited (SMPL) (CIN- U13209DL2004PTC125108) was incorporated in the year 2004 and is currently being managed by Mr. Ravindra Aggarwal and Mr. Mahesh Kumar Taparia. The company is engaged in trading of coal which is procured both domestically as well as imported as per the requirements. The company then sells it to traders and manufacturers of cement, steel, paper and various other industry all across India (particularly the UP belt).

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of SMPL into Issuer Not Cooperating category vide press release dated July 29, 2025 on account of its inability to carry out a review in the absence of requisite information.
