Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated March 12, 2025, placed the rating(s) of Richa Petro Products Limited (RPPL) under the 'issuer non-cooperating' category as RPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 26, 2026, February 05, 2026, February 15, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings. has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Richa Petro Products Private Limited (RPPL) was incorporated in the year 2010 by Mr. Ramesh Chandra Parida of Bhubaneswar, Odisha. The company has been engaged in manufacturing of pipes, pipe fittings, furniture, and water tanks of PVC (Polyvinyl Chloride). The main raw materials used in the production activity are Linear low-density polyethylene (LDPE), High-density polyethylene (HDPE), Polypropylene (PP) and PVC resin. The raw materials are procured mainly from Haldia Petrochemicals Limited and Reliance Industries Limited. The manufacturing plant of the company is located at Bhubaneswar, Odisha and it is well equipped with modern amenities along with ISO 9001:2008 certification. RPPL sells its products under the brand name of "Richa" (unregistered) through its established dealer network covering the state of Odisha only.
