Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 18, 2025, placed the rating(s) of Dharanii Cotton Mills Private Limited (DCMPL) under the 'issuer non-cooperating' category as DCMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DCMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 01, 2026, February 11, 2026, February 21, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
