### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated February 27, 2025, placed the rating(s) of Natraj Rice Mills Private Limited (NRMPL) under the 'issuer non-cooperating' category as NRMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NRMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 13, 2026, January 23, 2026, February 02, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the Company

Natraj Rice Mills Private Limited (NRMPL) was incorporated in July, 2008 by Mr. Sandip Kumar Goel, Mr. Manoj Kumar Agarwal and Mr. Vivek Kumar Banka based out of Jharkhand, for the purpose of setting up a rice processing unit and a captive biomass power plant. The company commenced operations in April 22, 2014 with paddy processing capacity of 96,000 metric ton per annum (MTPA) and 1.2 Mega Watt (MW) captive biomass power plant. The milling unit and power plant of the company is located at Lakhisarai district of Bihar. The company sells its products under the brand name "Magadh", "Koshi" and "Kamdhenu" to traders and wholesalers located in different states of India

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of NRMPL into ISSUER NOT COOPERATING category vide press release dated July 25, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
