Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 24, 2025, placed the rating(s) of M S Ahuja Agrofoods Private Limited (MSAAPL) under the 'issuer non-cooperating' category as MSAAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MSAAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 07, 2026, February 17, 2026, February 27, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of MSAAPL have been revised on account of non-availability of requisite information.
