### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 21, 2025, placed the rating(s) of R.K.I. Builders Private Limited (RBPL) under the 'issuer non-cooperating' category as RBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 07, 2026, March 17, 2026, March 27, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the Company

Incorporated in April 2003 as a Private Limited Company, RKI Builders Private Limited (RBPL) was promoted by Mr. A. Rajendra Prasad (Managing Director), Mr. T. Satish Kumar (Director) and Mr. K. Sridhar Reddy (Director). RKI is an ISO 9001:2008 certified company and focuses on construction projects for the government and public sector entities and trading of construction material (majorly steel and cement). During FY15, total operating income constituted 75% from civil construction works and rest 25% from trading of raw material.

**Status of non-cooperation with previous CRA:** India Ratings has continued the ratings assigned to the bank facilities of RBPL to 'Issuer Not Cooperating' category vide press release dated December 19, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.

Brickwork has continued the ratings assigned to the bank facilities of RBPL to 'Issuer Not Cooperating' category vide press release dated April 13, 2026 on account of its inability to carry out a review in the absence of the requisite information from the company.
