### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 29, 2025, placed the rating(s) of Pawan Kumar Kanoi (PKK) under the 'issuer non-cooperating' category as PKK had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. PKK continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 15, 2026, March 26, 2026, April 04, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Kolkata (West Bengal) based Pawan Kumar Kanoi (PKK) was established in year 1978 as a proprietorship firm by Mr. Pawan Kumar Kanoi. The firm is into trading of iron and steel products like hot rolled sheets, hot rolled/cold rolled coils and plates, angles, channels, mild steel pipes, mild steel nuts, bolts, flat, round, sponge iron etc. The firm is a distributor of Tata Steel Limited for the state of West Bengal since September 2019.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of PKK into Issuer Not Cooperating category vide press release dated January 31, 2026 on account of its inability to carry out a review in the absence of requisite information.
